- 1. Call meeting to order/roll call: Marilyn Patsch called the meeting to order. Present: Marilyn Patsch, Jeremy Lewis, Jake Bennett, Tylor Jamison, Jason Swerczek. Absent: None.
- **2. Approve the Village of Garland 2023-2024 budget:** Motion by Lewis to approve the Village of Garland's 2023-2024 Budget. 2nd by Swerczek. All aye.
- 3. Introduction and passage of Resolution #2023-5 approving the 2023-2024 budget: Resolution Adoption of 2023-2024 Village of Garland Budget Resolution #2023-5 was introduced and read by Lewis. BE IT RESOLVED by the Village Board of Garland, Nebraska that The Village of Garland 2023-2024 Budget is hereby approved as presented by said Village Board. Adopted this 26th day of September 2023 at Garland, Nebraska. Motion by Lewis to approve Resolution #2023-5. 2nd by Jamison. All aye.
- 4. Introduction and passage of Resolution #2023-4 setting property tax request: Resolution Setting the Property Tax Request Resolution #2023-4 was introduced and read by Lewis. WHEREAS, Nebraska Revised Statute 77-1632 and 77-1633 provides that the Governing Body of the Village of Garland passes by a majority vote a resolution or ordinance setting the tax request; and WHEREAS, a special public hearing was held as required by law to hear and consider comments concerning the property tax request; NOW, THEREFORE, the Governing Body of the Village of Garland resolves that:
 - 1. The 2023-2024 property tax request be set at: General Fund: \$62,629.52 Bond Fund: -
 - 2. The total assessed value of property differs from last year's total assessed value by 7.69 percent.
 - 3. The tax rate which would levy the same amount of property taxes as last year, when multiplied by the new total assessed value of property would be 0.417873 per \$100 of assessed value.
 - 4. The Village of Garland proposed to adopt a property tax request that will cause its tax rate to be 0.45 per \$100 of assessed value.
 - 5. Based on the proposed property tax request and changes in other revenue, the total operating budget of the Village of Garland will increase (or decrease) last year's budget by 0.17 percent.
 - 6. A copy of this resolution be certified and forwarded to the County Clerk on or before October 15, 2023. Motion by Lewis to pass Resolution #2023-4. 2nd by Jamison. All aye.
- 5. Vote on additional 1% increase in the restricted funds subject to limitation: Motion by Lewis to increase the restricted funds subject to limitation by an additional 1%. 2nd by Jamison. All aye.
